Comments:

- For getting ready for exam which is in Dec. of each year you have to have at least 80 % of the CP gathered by Nov. 1<sup>st</sup> of this year. The balance can be done in November and December itself or in the first three month after exam. This applies to the theory classes as well.
- And: for CPD/CPT at least 50 % of Theory classes must be in connection with one's own field of work; that means: For CPD it must be on reflection of group processes or individual development work and for CPT it must be on group or individual therapy (and the conductor must be a therapist, psychologist or MD). Exceptions may apply
- Supervision and Log on Practical work (P-Log) can be done even up to one full year after exam. The supervision is mainly to be done on the practical work (preparation and execution of own work and one's own role). The supervisor has to be approved by VIPL / MIEÜ before starting the supervision. Please look at the certification scheme: 1 CP Supervision is: a) individual supervision on 1-to-1 = 6 Hours; 1 CP in groups of 5 participants = 1 full day (7,5 time hours); 1 CP in groups of 13 = 3 full days (3 times 7,5 time hours)
- The A-log has to be handed in (especially for any exceptions) as early as possible best by Feb 25<sup>th</sup> of each year (as the annual report is given to the MIEÜ by beginning of March) and latest if exceptions are needed or you apply for exam by **Oct 15<sup>th</sup> of the year of exam.**
- Pls ask for exceptions early, as the decision process between India and Germany sometimes takes longer.
